Dear Professor Mann,

The conditions of employment – including the place of work and the assigned duties – are determined by the employer, not by medical professionals. A doctor cannot dictate how an employer is to accommodate someone (i.e. cannot specify duties or courses). The doctor is to provide the University with restrictions, limitations and barriers imposed by the underlying medical condition(s), and the University's Occupational Health unit will explore solutions which satisfy these restrictions in the context of your faculty position and its duties. This exploration is conducted by UW Occupational Health in connection with your own doctor. Neither the Director of CS nor I are medical professionals, and we are not in a position to assess the underlying conditions and needs; moreover, in keeping with provincial privacy legislation we are not privy to personal medical information. Thus, these solutions can only be explored by working with UW Occupational Health.

The accommodation that you had in place pre-pandemic is the accommodation agreement from 2011; these are the accommodation restrictions that I followed when I served as Director of CS. I have reviewed your proposed teaching assignment for the upcoming year, and find it to be consistent with this agreement. In the absence of any other approved accommodation, I would like to confirm the teaching assignment for the upcoming terms (F22 and W23), as assigned by the Director of CS. Any changes to this or further accommodation agreements must be handled through application to UW Occupational Health.

Dear Professor Mann.

I am writing in response to your April 26 and May 2 emails which I have read and considered.

Decisions related to teaching duties are made at the department and faculty levels. Accordingly, I am not in a position to reinstate your former teaching duties (nor would I be in a position to determine the teaching duties for any other faculty members in Computer Science, or any other department).

With respect to possible new medical accommodations, I will echo the statements made by Dean Giesbrecht in his April 23 email. The process for putting new medical accommodations in place would generally entail the following. You would first submit appropriate medical documentation to Occupational Health, to allow Occupational Health to assess your restrictions. This would be followed by discussions between you, Occupational Health, your Department and, if you wish, FAUW, to develop a plan and to put appropriate accommodations in place, based on your medical restrictions.

I hope this email helps to clarify matters and, if you do require further medical accommodation, I would encourage you to continue to engage with Occupational Health.

Dear Professor Rush

Context:

I have encountered many difficulties at Waterloo. These may broadly be described as a toxic work environment, which has also taken on academic bullying, both before and after the Pandemic.

These issues began soon after I arrived at Waterloo. I began seeing the FAUW about performance reviews and the lack of clarity on this topic. I have what some may call a disability, others may would call it anxiety and depression. The result is that I am unable to function when there is a lack of clarity or transparency and for this reason I became involved with FAUW and Occupational Health.

These were already mentioned in my Appeal of suspension (Nov 17, 2021, Attached). I refer you to submitted material "Additional comments regarding the lack of consultation between the Dean of Mathematics and myself which must also be taken into consideration".

My previous accommodation focused on performance reviews, and on control over timing and choice of my teaching duties. In addition to duplicate sections, I was allowed control over sections so that I was not co teaching with others, a significant problem for me in the past. I began negotiation with Sally Gunz and after many unsuccessful attempts, achieved an agreement in 2011. At that point we instituted a fixed performance review number and this was approved by a former Provost.

Since 2011 a lot has changed. In particular, I took medical leave in 2014, and did not return to teaching until 2016. Beginning 2016 I developed my own course, a project based course, which has high engagement students and has allowed me to flourish

both in instruction and research.

As mentioned in previous correspondence I have continued to teach my project course, while negotiating with Lori Curtis (FAUW, current President). This negotiation was ongoing until the Pandemic started.

Request:

I am writing to ask that you,

- 1. Re instate my teaching duties to those before my medical leave.
- 2. Begin a new negotiation of medical accommodations, with a goal of achieving a negotiated settlement on a finite duration time window.

I remind you that medical accommodations do not specify a required work load or specific duties.

So far neither the Chair nor the Dean has addressed those issues. In fact, they have ignored my most recent medical documentation.

<u>I ask that you inform me of your decision as soon as possible and certainly before my back to work date.</u>
